6,344,010 units (the "Units") in OUE Commercial Real Estate Investment Trust ("OUE C-REIT") had been issued to OUE Commercial REIT Management Pte. Ltd. (the "REIT Manager") on 2 February 2021 as payment for 50% of the REIT Manager's base fee for the period from 1 October 2020 to 31 December 2020 (the "2 February Issuance"). As a result of the 2 February Issuance, the REIT Manager has a direct interest of 211,239,508 Units (the "RM Units").

The REIT Manager is a wholly-owned subsidiary of OUE Limited ("OUE"). Accordingly, as a result of the 2 February Issuance, OUE has a deemed interest in the RM Units as well as (i) a deemed interest of 1,471,601,271 Units held by Clifford Development Pte. Ltd., a wholly-owned subsidiary of OUE, (ii) a deemed interest of 127,749,410 Units held by OUE Hospitality REIT Management Pte. Ltd., a wholly-owned subsidiary of OUE, and (iii) a direct interest in 795,658,724 Units, amounting to a total interest in 2,606,248,913 Units (the "OUE Units").

OUE Realty Pte. Ltd. ("OUER") is the holding company of OUE. Accordingly, as a result of the 2 February Issuance, OUER has a deemed interest in the OUE Units in which OUE has an interest as well as a direct interest in 25,807,700 Units, amounting to a total interest in 2,632,056,613 Units (the "OUER Units").
