OUEHRMPL has transferred 127,749,410 units in OUE C-REIT to OUE for an aggregate consideration of S\$54,293,499.25.

Accordingly, as a result of the above transaction, OUE has (i) a direct interest in 923,408,134 units, (ii) a deemed interest of 225,996,882 units held by OUE Commercial REIT Management Pte. Ltd., a wholly-owned subsidiary of OUE, and (iii) a deemed interest of 1,471,601,271 units held by Clifford Development Pte. Ltd., a wholly-owned subsidiary of OUE, amounting to a total interest in 2,621,006,287 units.
